Subcontractor will be paid by client one week in advance. Subcontractor to arrange to have client send payment directly to subcontractor. Check or money order, etc. is to be made payable to subcontractor.

Unless agreed to in writing by Hugh Swanke, all subcontractors shall abide by the following conditions:

Arrival time is at least one hour prior to start time. Subcontractor must wear a tuxedo in good condition unless specified above, and be well groomed. Unless specified by client at least one meeting is required to take place between subcontractor and client at least four (4) weeks before event, unless contract date is less than four (4) weeks. Subcontractor shall give their home phone number to client within three (3) days of signing this agreement. **All subcontractors agree to freely distribute business cards or fliers for A New Song Mobile Entertainment only at event, or to attendees of the event. No other marketing literature of any kind for any other company, person or service other than for A New Song Mobile Entertainment or A New Song Wedding Coordinators shall be distributed to anyone at the event before, during or after the event on that day.** When unanticipated events result in default of this contract, Hugh Swanke's liability shall be limited to the value of the deposit received from client. Should subcontractor default, they shall be liable for any damages and/or claims resulting from client legal action brought against Hugh Swanke, A New Song Mobile Entertainment, any assets, assigns, agents or associates of either party. All subcontractors will be completely responsible for any and all State and Federal Workers Compensation benefits and job related injuries/liabilities, as well as any tax liabilities from income as a subcontractor, as well as any necessary insurances including liability insurance. **Absolutely no substitute talent(s) may be assigned to this contract without expressed, written consent of Hugh or Pam Swanke.** The undersigned subcontractor also agrees not to solicit Hugh Swanke's clients, associates, or other vendors originally met through this contractual service by any means other than as an agent for this company for a period of 24 months. Subcontractor is responsible for the care of all equipment owned by Hugh or Pam Swanke used for this event, to repair or replace such equipment if necessary, within five (5) business days, from the time it is picked up by subcontractor until the time it is received by Hugh Swanke.
